NOTICE OF CITY COUNCIL SPECIAL MEETING (Electronic)

The Cedar Rapids City Council will hold an electronic special City Council meeting on Friday, November 20, 2020 at 10:00 AM. An electronic meeting is being held because a meeting in person is impossible or impractical due to concerns for the health and safety of Council members, staff and the public presented by COVID-19. An electronic meeting is allowed by Iowa Code Section 21.8 and Governor Reynolds’ Proclamations of Disaster Emergency.

The meeting may be watched on the City’s Facebook page at www.facebook.com/CityofCRiowa/. Members of the public will not be able to attend this meeting in person. Any persons interested in commenting on the agenda items may do so in writing by emailing cityclerk@cedar-rapids.org. Comments must be received before 8:00 AM on November 20 in order to be provided to the members of the City Council prior to the meeting.
